1 To receive apologies for absence.

Apologies of absence were received from Cllr. Coxhead, Cllr. Morley, District Cllr. Culver and Mr. Hole (Yattendon Estate).

Declarations of Interest.

2.1 To receive declarations of interest.

There were no updates to the Register of Interests.

2.2 Declaration of Interest in Agenda Items.

Cllr. Allum declared an interest in the allotment fencing as an allotment holder.

To approve minutes of meeting.

The minutes of the meeting of FPC held on 12th July 2023 were corrected and will be signed by Cllr. Allum.

4 Matters arising from the minutes.

4.1 Vehicles parked at the back of Beechfield.

Vehicles remain parked at the back of Beechfield and have not been moved. WBC are not making progress with removing them.

4.2 Verges.

Verges have not been cut and as a result safety is being compromised. Brocks Lane, Pot Kiln Lane and Wellhouse Lane are particularly bad.

5 Report from Yattendon Estate.

There was no report from Yattendon Estate.

6 Planning

6.1 Planning applications on which FPC has been consulted by WBC:

6.1.1 23/01686/FUL – Orchard Day Nursery, Everington Bungalow, Everington Hill (Yattendon Parish).

Change of use of the existing building from a day nursery to a residential dwelling and erection of extensions following the demolition of the existing conservatory.

FPC has **objected** to this application which is to be considered by the Western Area Planning Committee (WAP) on Wednesday 20th September.

FPC will not make representation at the WAP.

6.2 Planning Decisions made by WBC:

No decisions have been made by WBC on any planning applications in Frilsham.

6.3 Pre-consultation on Cornerstone 12489428, Yattendon Road.

Proposed base station installation upgrade at Cornerstone 112489428, Hermitage Spring Plantation, Yattendon Road, Hermitage. RG18 0XU

FPC feel that a tree style mast would be less intrusive.

West Berkshire District Councillors Report (submitted prior to the meeting by District Cllr. Culver).

7.1 Planning.

At WAP on 20th September we will be considering Everington Bungalow application Ref 23/00552/HOUSE in Yattendon parish.

At the last WAP the latest set of planning conditions for the Compton Institute were discharged. Homes England, the current landowner, is in touch with Compton and East Ilsley PCs and has reassured us it will communicate with residents via Compilations magazine and social media, and letters in the case of immediate neighbours of the site. Demolition began officially just after bank holiday Monday.

The Downs School sports hall was approved by WAPC too, but Compton PC and myself raised concerns about a number of matters including the impact on parking and public access to the facility. I'm in touch with some of the coaches who provide public sport and have asked them to let me know if they encounter more problems with WBC and the contractor Everyone Active.

7.2 Members' Community Bids.

The council's annual 'Members' Community Bids' scheme is open. Deadline is 31st October. I can apply for £5,000 in match funding.

7.3 WBC Finances.

West Berkshire Council issued a press release on 22nd August about its finances. 'West Berkshire Council has implemented an action plan to reduce spending this year as it continues to be affected by rising inflation, increasing customer demand and a challenging job market. Spending reductions will be focused on internal measures with frontline services remaining available to the public and future spending prioritised towards supporting our most vulnerable residents. Forecasts earlier in the year showed an £8.7m overspend by year-end but measures put in place already have reduced this to £6.3m. The ongoing benefits of this work together with new measures should deliver a break-even position by the year end. The overspend is being driven by an increasing demand for social care as well as the increasing costs of providing the care, the cost of delivering Home to School Transport as well as the impact of inflation and high levels of agency worker costs.' Full press release is on the council's website.

7.4 Recreation Facilities.

West Berkshire Council has opened the Northcroft Lido and is still planning to re-open Faraday Road football pitch.

7.5 Scrutiny Commission.

On 14th September the new Thames Valley Superintendent will be attending Scrutiny Commission to give a presentation and answer questions. On 11th October, Thames Water and the Environment Agency will attend the Commission to make presentations and answer questions. I am also chairing two 'task and finish' groups (sub-committees) looking at lessons learned from the covid pandemic, and one looking at healthcare provision in new housing developments. Scrutiny will also play an important role in combing through the council's finances and making recommendations for savings and income generation.

8 Playground and Facilities around the Club Room.

8.1 Update on the bin situation.

The new contractor Tactical has emptied all of the bins every week and so far have been a huge improvement.

8.2 Update on the Play area.

Whilst the vegetation has been cut back, ideally it needs to be cut back between the two fences. Cllr. Allum will obtain replacement fence posts and organise a working party to repair the fencing.

Cllr. Allum has tightened the bolts on the zip wire.

The fence between the car park and the football pitch needs repair, however, there has been an issue sourcing the correct sized timber. Cllr. Lyon will continue his search.

12.1.5 | Community Speed watch Seminar.

WBC has organised a Community Speed Watch (CSW) seminar to take place in the WBC Council offices on Wednesday 25th October at 6pm. Thames Valley Police (TVP) will be at the event and able to answer questions about the CSW which is operated by TVP. The TVP CSW results in any drivers exceeding the Association of Police Officers (ACPO) speed receiving warning letters. If the same vehicle is reported speeding on 3 separate occasions, TVP will make a visit in person to the registered keeper of the vehicle.

12.2 Items for The Broadsheet.

A summary of the meeting will be submitted to the Broadsheet with the new councillors and the new bin emptying contract being specifically mentioned.

13 Finances.

13.1 Financial Statement.

Cllr. Lyon reported that Fast hosts currently migrate websites. The cost for hosting the website for the first year is approximately £30, which will rise to approximately £60 in subsequent years. Fast hosts provide 25GB of storage; the current website uses approximately 2GB. Fast hosts may also offer email addresses. Cllr. Lyon will continue to explore options.
